INVITATION TO BID FOR SUPPLY AND DELIVERY OF PROFESSIONAL & GENERAL EDUCATION BOOKS FOR THE NEW CURRICULUM

- 1. The Surigao State College of Technology (SSCT), through the General Appropriations Act (GAA) SY 2020 intends to apply the sum of One Million Six Hundred Twenty-Two Thousand Four Hundred Sixty Pesos (P 1,622,460.00) being the Approved Budget for the Contract to payments under the contract for SUPPLY AND DELIVERY OF PROFESSIONAL & GENERAL EDUCATION BOOKS FOR THE NEW CURRICULUM under PB No. 21-04-0003. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. **SSCT** now invites bids for the above Procurement Project. Delivery of the Goods is required by *thirty* (30) Calendar days upon receipt of Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from **SSCT** and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m. Mondays to Fridays except during declared Holidays and suspension of work.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders upon payment of the non-refundable fee for the Bidding Documents through:
 - a. Cashier Section, 1st Floor, SSCT Building, Narciso St., Surigao City; or

- 6. **SSCT** will hold a Pre-Bid Conference¹ on *May 21, 2021, 2:00 p.m.* at *Learning Resource Center, SSCT, Surigao City* and/or through video conferencing or webcasting *which* shall be open to prospective bidders. Meeting link and password will be sent upon the request of the prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below or sending the bid through a courier, on or before 2: 00 p.m. of June 3, 2021. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on *June 3, 2021, 2:00 p.m.* at the **Learning Resource Center, SSCT, Surigao City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. **SSCT** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
