## INVITATION TO BID FOR REHABILITATION & REPAIR OF ADMINISTRATION BUILDING - DEL CARMEN CAMPUS

1. The *Surigao State College of Technology*, through the *Corporate Budget for the Contract Approved by the Governing Board* intends to apply the sum of Two Million Six Hundred Ninety-Seven Thousand Seven Hundred Fifty Pesos & 75/100 (P 2,697,750.75) being the Approved Budget for the Contract (ABC) to payments under the contract for **Rehabilitation & Repair of Administration Building - Del Carmen Campus**. Bids received in excess of the ABC shall be automatically rejected during the bid opening.
2. The *Surigao State College of Technology* now invites bids for **REHABILITATION & REPAIR OF ADMINISTRATION BUILDING - DEL CARMEN CAMPUS**. Completion of the works is required for **Sixty (60) Calendar Days**. Bidders should have completed, within **10 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidder.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary **"pass/fail"** criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from **Surigao State College of Technology, Narciso Street, Surigao City** and inspect the Bidding Documents at the address given below from **8:00 AM - 5:00 PM, Monday to Friday**.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Php 5,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of Surigao State College of Technology ([www.ssct.edu.ph](http://www.ssct.edu.ph)) provided that Bidders who are interested to participate shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids. The bidder can purchase the bidding documents upon presentation of at least **PCAB License (General Engineering) Category D** and **Liaison Officer (DPWH Accredited)**.

6. The *Surigao State College of Technology* will hold a Pre-Bid Conference on **March 22, 2022, at 9:00 AM at Bids and Awards Committee Office (BAC); 2nd Floor, SSCT Building**, which shall be opened to all interested parties.
7. Bids must be delivered to the address below on or before **April 4, 2022, @ 9:00 A.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
