Invitation to Bid for the Repair & Improvement of Multi-Purpose Gym (Damaged by Typhoon Odette) – Malimono Campus

1. The *Surigao del Norte State University (SNSU)*, through the *Corporate Budget for the Contract Approved by the Governing Boards* intends to apply the sum of **Five Million Pesos (P 5,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the ***Repair & Improvement of Multi-Purpose Gym (Damaged by Typhoon Odette) – Malimono Campus*** under ***PB# 23-05-0017***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Surigao del Norte State University (SNSU)* now invites bids for the ***Repair & Improvement of Multi-Purpose Gym (Damaged by Typhoon Odette) – Malimono Campus***. Completion of the Works is required for ***One Hundred Fifty (150) Calendar Days***. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Surigao del Norte State University (SNSU)*, *Surigao City* and inspect the Bidding Documents at the address given below from **8:00 A.M.- 5:00 P.M., Monday to Friday**.

6. The *Surigao del Norte State University (SNSU)* will hold a Pre-Bid Conference¹ on ***August 16, 2023 at 2:00 P.M. at the Bids and Awards Committee Office (BAC); 2nd Floor, SNSU Building*** or through videoconferencing/webcasting ***via Zoom***, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **August 29, 2023, @ 2:01 P.M. at the Office of the Bids and Awards Committee; 2nd Floor, SNSU Building, Narciso St., Surigao City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Surigao del Norte State University (SNSU)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
